FAQs

HOW DOES FRENZI DIFFER FROM OTHER TAXI APPS LIKE UBER?

Frenzi operates on a different business model compared to traditional taxi apps. We do not charge a percentage fee to drivers. Instead, drivers only pay a small 57p acceptance fee for each ride they accept. This allows drivers to keep more of their earnings and provides a fair and transparent pricing structure.

CAN DRIVERS WORK FOR MULTIPLE TAXI APPS SIMULTANEOUSLY?

Absolutely! Frenzi allows drivers to work for as many taxi apps as they like. We understand that drivers may want to maximize their opportunities and income, so we provide the flexibility to choose multiple platforms without any restrictions.

IS THERE A SUBSCRIPTION FEE FOR DRIVERS?

No, there is no subscription fee for drivers on Frenzi. We believe in empowering drivers by eliminating unnecessary costs, allowing them to focus on providing excellent service and earning a fair income.

CAN RIDERS CHOOSE THEIR PREFERRED DRIVER?

Yes, riders have the ability to select their preferred driver. Our app provides driver profiles with relevant information such as ratings, reviews, and vehicle details, enabling riders to make an informed decision based on their preferences.



HOW DOES THE BIDDING SYSTEM FOR PRE-BOOKED JOBS WORK?

Frenzi offers a unique feature where drivers can bid for pre-booked jobs. When a rider schedules a future ride, drivers have the option to submit bids, including their proposed fare, for consideration. The rider can then choose the bid that best suits their needs, providing flexibility and potential cost savings.

FINANCIAL TERMS

MINIMUM JOB ACCEPTANCE FEE:

Each city has a minimum amount that you'll make for any trip. Our app ride fare tariffs will work in conjunction with each UK licenced taxi borough fare rate. This makes sure your earnings reflect the effort you put in, even on short trips.

SURGE FARES:

During peak operating times and dates, our fare tariffs will raise based on service requirements. Our membership structure means that you will be the sole beneficiary of this!

PAYMENT TERMS:

Upon successful registration with the app (see page 8) your ride fares will be directly paid into your bank account set up with Frenzi.

Automatic payments are calculated on a weekly cycle. This means that any trip taken after the end of the weekly cycle will appear in the following week's payment statement.

Weekly cycle payments should appear in your account no later than 2 business days after the cycle, please note this is dependent on the bank account you have connected to Frenzi Apps UK Limited.

SELF ASSESSMENT & TAX DETAILS:

Please note it is your responsibility to ensure your VAT records are operating in accordance with your Governments regulations. You are not directly employed by Frenzi Apps UK Limited.

We will keep providing you with annual tax statements to assist with your annual self assessment for income tax purposes - and we will always look for ways to make this information more helpful.

- ✓ Driver profile photo
